LLANRUG COMMUNITY COUNCIL GRANT

The purpose of the scheme is to enable Llanrug Community Council to provide financial assistance to family's whose gross household income is £16,190 or less and in receipt or eligible to receive one of the above benefits, for the purchase or hire of:

- School uniform including coats and shoes;
- School sports kit including footwear;
- Uniform for enrichment activities, including but not limited to, scouts; guides; cadets; martial arts; sports; performing arts or dance;
- Equipment e.g. school bags and stationery;
- Specialist equipment where new curriculum activities begin such as design and technology; and
- Equipment for out of school hours trips such as outdoor learning e.g. waterproofs. This is not an exhaustive list.

The Funding (up to £100 per pupil) is available for families whose child: -

- who is attending a school located within the area of the Council on the date of application;
- who has been registered at the school since the beginning of term, unless moved into the area mid term
- whose attendance at the school is satisfactory;
- who is living within Llanrug Community Council area although may be receiving their education elsewhere.

If you are unsure if your property is within the Llanrug Community Council area, you should contact the Council.

You must provide evidence to Llanrug Community Council of your entitlements to any of the benefits referred to above, which must be enclosed with this application. Where expenditure has already been made, receipts must be provided with the application or arrangements may be made for the Council to pay the supplier direct. YOU SHOULD NOT COMMIT TO ANY EXPENDITURE UNLESS YOU HAVE HAD THE WRITTEN AUTHORISATION OF LLANRUG COMMUNITY COUNCIL.
