I raised this with the Police at the Eisteddfod held in Tregaron, and they told me that they have a scheme named Community Speed Watch where the police train the public on how to use Speed guns. The evidence is used by the Police to send a warning letter to the driver for speeding. The evidence collected will help the Police to decide when and where to locate its Safety vans. We must establish a group of 6, or more, volunteers to work in pairs to measure the Speed. The next step is to
