Constant concern is being expressed on how tight it is at the top of Station Road when cars are parked on each side of the road below Co-op. The main concern is that an ambulance or fire Engine wouldn't be able to pass due to the vehicle situation when it is at its worse. Discussions are continuing with the Environment Department on possible solutions to the issues with Station Road. Concerns have also been raised about people parking at the corner of Spar making visibility difficult and unsafe for people using the pavement. An idea for a possible solution has been sent to the council. It was also noted that the area around the band hut is very busy at specific times of the day – such as during the school run – and that traffic comes from every direction. She will be discussing this situation with the relevant department.

COUNCIL

Following being appointed as a Cabinet Member with responsibility for Education, it has been a period of briefing meetings to learn about all the various aspects of the department.

A statement on the developments regarding Free School Lunch has been issued; this is as a result of the agreement between the Party of Wales and the Welsh Government. Each child at Reception Class will receive free school lunch from September onwards and each child in year 1 and 2 from April next year.

I welcome this agreement and I'm looking forward to seeing the scheme commencing in September as it will go some of the way to at least easing the impact of the cost-of-living crisis. It will also encourage healthy eating habits in children and will maybe improve the children's ability to concentrate in the afternoon because each child will have received a hot meal.
