A note regarding the sewarage network of Llanrug. Hefin will make a note of the visit and the work itself. Reiteration is possible.

The first point is that the network, as the is the case with the majority in the area, is "combined". This means that the rainwater and the dirty water enters the network. Therefore, the volume which is poured from the works to Seiont isn't consistent.

The works treats up to 17.6litre/second of sewerage. This is the largest volume which enters the Seiont after being treated to the standard, or better than standard, which is permitted by Welsh Water.

In wet weather, the flow which is above the 17.6 litre/second enters the storm tank at the works, and after settling a while in the tank, it overflows to the Seiont. This shouldn't cause environmental concern as there will be more water in the river as well.

If the weather is even wetter, the network overflows via the "Combined Sewer Overflow", CSO, which is the pumping station across the road from Penbont. Here, the flow which is over 26.5 I/3 overflows to the Seiont.

I wanted to know from Welsh Water, what is the condition of the network, if it will affect any new developments in the area. According to Welsh Water, there are no defects at present. There were defects some years ago at Glanffynnon

and Pont Rhythallt. Work to resolve those issues was completed during 2018-19.

In the Seiont area there are 9 sewerage treatment works – 2 at Dinoriwg, Gallt y Foel, Nant Peris, Penisarwaun, Deiniol / Brynrefail, Llanberis, Llanrug and Caernarfon 26 pumping stations and 26 CSO

According to Welsh Water's website they have started a project to consider how their assets would cope in the future with more heavy rain likely in the future due to climate change. They will be considering taking clean water out of the dirty water network. This will be over the period 2030-50. It will not be easy and will be expensive. They intend to consult with Natural resources Wales, Councils etc. Is anyone aware of this? Has the process started? In my opinion, it's important that the Community Council should have input to the consultation.
