1174. To receive a joint report from Councillor Beca Brown and Berwyn Parry Jones, the members for Cwm y Glo and Llanrug on Gwynedd Council

Cabinet Meeting: 13 June

Report by the Planning Department introducing Article 4 instruction which will introduce 3 types of houses, the main home, second home and holiday accommodation. This will mean that planning permission will be required to change a residential house to a second home or holiday lets. The intention is to ensure that no more second home and holiday lets will be permitted in areas where there are already too many. This will come into force in a year's time following consultation.

Report by the Education Department on Gwynedd's response to Welsh Government consultation on a Welsh Language Education Bill. The response has been supportive regarding what Welsh Government are trying to achieve. These are the two main points.

- clear and firm focus on the language outcomes for pupils and this should be the main principle of the proposals for the Bill.
 - By 2050 every pupil who leave statutory education can speak Welsh confidently.

Report by the Housing Department which provided an update on the Housing Action Plan – this was created when the council tax was raised 50% in the first

instance, and then raised to 100%. This has given the opportunity to create some more schemes, but not as much as there would have been, because the cost of products has increased so much, which means that the costs of some pipeline schemes has increased substantially. Of course, the premium has gone up 150% by now, but the last increase has gone towards additional costs of homelessness. A very difficult situation with costs increasing to approximately £3 million a year. A sad statistic is that someone declares themselves homeless every hour and a half in Gwynedd.

General

Problems have been in the area with waste and recycling collections often being missed. I have met with officers and the main issue is sickness in the workforce and some machines breaking down, adding to the issues. They have plans in place and hopefully these problems will be resolved in the next month or two.

I have attended, and spoken, to Gwynedd licensing sub-committee regarding Bryn Teg Holiday Park to extend their licence. Has turned out better than I expected. They have revoked their application for wrestling and boxing, and they have offered to revoke outside entertainment from the licence. They have also agreed to tighter conditions. This is an improved licence from the resident's perspective compared to the previous licence.

Beca, I and all other members of the cabinet have attended Carbon Literacy Training, as part of the council's decision to become net zero by 2030.

Beca has been on a visit to Tyddyn Teg and Ysgol Brynrefail with Hywel Williams. The school has had a grant to develop the connection for the crew at Tyddyn Teg attends the school to educate pupils on how to grow produce etc. There is a path from Tyddyn Teg to the school; however, work is required to clear the path. Beca will be working with Sasha, the councillor for Bethel to try and clear the path, so that pupils can walk between the two, rather than using the minibus which is the current mode of transport.

Beca has been volunteering at the trwsio café at the Institute on a Saturday, the café has been a huge success with several attending to repair various equipment. There were stalls for repairing bikes, electrical goods, and mending clothes.

Dyfi Biosphere Partnership

I attended my first meeting of the Dyfi Biosphere Partnership. Dyfi Biosphere was established in 2009 as part of UNESCO biospheres family, the only one in Wales. The idea is to build a regenerative decarbonised economy.

The problem is that there is no financial assistance with the project. There are several small projects within the area. A meeting has been held with Julie James, to try and ensure some form of financial commitment to support

larger projects. All those present felt that they had a fair hearing. We will see what will come.
