Reported that we had a warm welcome and a tour of the warehouse to see the arrangements.

The meeting was exteremly helpful and it seems that a solution to the matter has been found.

Cabinet Meeting 11 July

The Highway guidebook was adopted. This will provide a clear stretagy to the Council on how to treat potholes in roads. Also, it will change the way in which road maintenance is funded. In the past, it was funded on the basis of how many miles of roads were in each area. The new strategy will priortise in accordance to the risk.

General

Both of us attended training:-

- 1. Mental Health Awareness Training an internal course held by the Council.
- 2. National Training for School Governors on the impact of child poverty on their education and how to address.

Welsh Government had decided not to fund free meals over the summer holidays this year, for those children who usually have a free meal, Beca will present a proposal to the Cabinet on Thursday that Cyngor Gwynedd funds this.

Post-meeting note: The propsoal to fund meals was unanmioulsy accepted by the Cabinet.

I recently attended a meeting of the Climate Change Board:-

The Council aims to be zero net by 2030. Much of the carbon emmissions accounted for derives from the procurement process, And of course, this is the most difficult area for the Council to tackle, as its out of the council's control.

Still working on establishing a green fleet, SP Energy cannot keep up with setting up charging points. It will be challenging to ensure that large lorries etc are greener

I attended a conference on managing the risks associated with flooding. This will be a huge challenge for us. The climate change crisis is obviously making matters worse.

Third sector liasion group – the first in-person meeting of the group since the pandemic was held at the Age Concern's offices, Bontnewydd. The purpose of the meeting was to see how the Council can help the sector, and how the sector can help the Council. All agreed that clear communication is essential

Received an update by the waste and recycling service – matters have progressed, but it will take time to see a difference in the service. A culture change is taking place, need to reduce sickness and overtime. The workforce and the Unions agree that the changes are required

Beca is keen to arrange another school uniform swap day, at the Institute in Llanrug. Parents will have the opportunity to get uniforms for their children, and also to bring any unwanted clothes to be recycled.

Beca has been successful in applying for the grant, Loneliness and Isolation, which is there to bring people together to socialise. She intends to hold afternon tea with entertinment at the Institute during the Autumn and Spring.

Dyfi Biosphere Partnership.

I attended another meeting of the Dyfi Bisophere Partnership.

Following a meeting with the Minister, Julie James, she committed monies for bigger projects to be funded. By now, she has agreed to allocate £30k to enable them to implement a better structure, they are looking at possibiliites at present – things like asking other organisations to accommodate them etc. A decision is expected by the next meeting.
