1297. Confirmation of the minutes of the meeting held on 25 March 2024

1298. To consider whether Llanrug Community Council should express an initial interest in taking the strip of land by Lon Groes following a meeting held on 25 March 2024.

Referred to a meeting held with the Institute's officers. Following this meeting, it was resolved to include this specific item on the agenda of the next meeting of the council.

The Councillors discussed the proposed development and its use. The Council was required to consider whether to express an initial interest in purchasing the land.

Resolved:

- a) Not to express an interest in purchasing the land for the following reasons
 - I. Uncertainty about the cost of the land
 - II. The project would be too big for the community council to cope with
- III. The community council would have to borrow a significant sum of money, not only to purchase the land but also to develop it after purchasing. This would mean that the council would be required to borrow the money and would result in a significant increase in the council tax to re-pay the loan and interest.
- IV. The council is interested in what will happen to the land, for the benefit of the community.

- b) There is enough money in the budget to pay for eggs and bread for approximately 3 ½ months. It is hoped that we can take advantage of grant opportunities.

- d) Noted that one application has been received for the discretionary grant for individuals. How to promote the scheme was discussed and it was agreed to send a letter to everyone who receives a food package, advertise on our website and Facebook, and send a letter to schools.

- 2.Other work to the cemetery: new parking signs regarding parking on the grass in wet weather, respecting the cemetery and report damage; implement the new recycling measures introduced by the Welsh Government. Repair a fence by block E & F.
- 3. Meeting of the Cemetery Sub-committee ,9.4.24. reviewed the rules of the cemetery and confirmed for 24/25; decisions on how to implement the new recycling measures introduced by the Welsh Government in a reasonable and practical way, i.e. keep the general waste bin, the green/plants (brown) waste bin, an opportunity to recycle plastic and visitors to take all other waste home; received a question and answer document regarding grass cutting which will be shared with the public.
