Playing field questionnaire

Reported that a questionnaire has been created. The primary school has been approached to ask if children could complete the questionnaire to decide on which additional equipment would be acceptable for Pwll Moelyn playing field. To date no response received from the school.

Reported that a defibrillator has been sited at Crawia and registered with 'The Circuit.'

Reported that the contractor hopes to site the bench at Cwm y Glo before the end of the week.

Reported on the following by Councillor Philip Roberts, chair of the committee.

- Following a written query by a local undertaker regarding the responsibility for digging new graves the Clerk responded by letter that there is no change to the current process. There is a risk to the council if we are not aware of who is digging a new grave, when, and which health and safety systems are used. As a result, it is possible that it will be required to collect the relevant information in the future.
- Following a written query by a member of the public regarding the church cemetery, the signs should be reviewed to check that they clearly note which organisation is responsible for which cemetery. The query also complained about the condition of the road to the church and cemeteries.
- Cemetery of the Year Competition 2024

The Cemetery of the Year national competition (UK) of the ICCM (Institute of Cemetery and Crematorium Management) results were announced on 24 September. Again, the Community Council won the silver award in its category. Congratulations to everyone that has contributed to the result and thank you all for your hard work over the last year.

Please note the context, the precept of the cemetery that won the Gold Prize, Blandford Forum Cemetery is £825, 250 for 23/24 and the council employs 16 members of staff. In joint second place, and winning the silver prize, Syston District Council. Their precept is £673,457 and they employ 13 members of staff. The Precept of the Community Council is £85,000 with one member of staff, the Clerk.
