Following a brief delay to ensure an issue involving land opposite the cemetery, the cemetery committee resolved at a meeting on 7 November to proceed with the work of building walls around land for an extension to the cemetery. The work will be completed by collaborating with the landowner.

At the same meeting it was resolved to complete health and safety work to upgrade the last twenty memorials which have been identified as needing the most attention following the latest risk assessment. Work will also be undertaken on the stakes of other graves.

On the advice of the contractor, it was resolved to have one more grass cutting at the cemetery this year.

The sub-committee have agreed to a request for assistance to deal with land which has sunk in front of a grave. Exceptional events such as these will be considered during our next review of the rules of the cemetery.

Resolved on the text for the signs that are to be ordered shortly: parking, closing gates, warning at the entry to the hut.

A meeting of the sub-committee to discuss the priorities for the cemetery for 25/26 will be held on 2 January at 6.30pn (on-line).
